

Regulations for accepting works for publication in the scientific journal "Heteroglossia - cultural and philological studies"

§ 1. Preliminary remarks

1. The scientific journal "Heteroglossia – cultural and philological studies" is open to the public. Authors from national and foreign research centers can publish there.
2. The organs of the journal are the editorial board and the scientific council.
3. The journal is published in the form of a semi-annual journal of the University of Economy with its office registered in Bydgoszcz, Garbary 2, 85-229 Bydgoszcz.
4. Texts for publication are accepted on a continuous basis and in the order of submission.
5. The editorial office accepts original, not previously published texts from the following disciplines: literary studies, linguistics, cultural studies and religious studies. Texts in different languages are accepted.
6. The journal publishes works in the form of an article, review article, review, report from a scientific conference, etc.
7. After receiving the work, the editorial secretary of the journal confirms its receipt, which is not the same as accepting it for publishing.
8. The editors possess the right to reject texts that do not meet the general requirements (§ 2. General requirements) and technical requirements (according to the instructions on the journal's website) or violating the principles of creating a scientific apparatus.
9. The editors of the journal make every effort to detect and disclose cases of dishonest practices, such as: plagiarism, multiple publications, unauthorized citations, etc.
10. The editorial staff considers ghostwriting and guest authorship as manifestations of scientific misconduct. If they are found, the editors reject the work.
11. Authors of published texts receive a traditional (printed) version of the journal.
12. The authors do not receive a fee for works published in the journal.

§ 2. General requirements

1. Only those texts that fit into the journal's profile and have been prepared in accordance with the technical requirements of the editorial office are qualified for review (instructions are included on the journal's website in the "For Authors" tab).
2. Submission of a text for review is considered by the editors to be tantamount to a declaration if:
 - 1) the text has not been submitted to another journal (a negative result of the review procedure releases the author from this contract) and has not been previously published;
 - 2) the text is the original work of the author/authors;
 - 3) the author does not infringe the copyrights of the results of scientific research and illustrative materials of third parties;
 - 4) the submitted text did not omit information about people and institutions that contributed to the achievement of the research results presented in the text;

5) information on research funding by domestic and foreign persons, institutions or organizations has not been omitted in the submitted text.

3. The legal consequences of scientific dishonesty (plagiarism, self-plagiarism) are borne by the authors of the works.

4. The author is obliged to sign an agreement with the editorial office on the transfer of economic copyrights to the extent enabling the publication of the work in a scientific journal "Heteroglossia – cultural and philological studies" in digital and printed versions and making the work available in free access (open access).

5. The requirement indicated in point 4, in the case of a multi-author work, applies to each of the authors.

§ 3. Publication fees

1. For accepting a work for the review process and for publication in the scientific journal "Heteroglossia – cultural and philological studies", publication fees are charged.

2. The amount of publication fees and the method of payment are made in accordance with the Instructions for making publication fees in the scientific journal "Heteroglossia – cultural and philological studies".

3. The instruction referred to in point 2 constitutes Appendix 1 to these Regulations.

§ 4. Responsibility and cooperation

1. In all matters related to running the scientific journal "Heteroglossia – cultural and philological studies" concerning contact with authors and other persons, the editors of the journal are responsible.

2. In particular, the editors of the journal answer the questions of authors and reviewers.

3. In matters related to settlements, the editorial office of the journal acts in consultation with the Bursar of the University of Economy with its registered office in Bydgoszcz.

4. The publisher of the scientific journal "Heteroglossia - cultural and philological studies" is Wydawnictwo Wyższa Szkoła Gospodarki in Bydgoszcz, belonging to the Group Publishing University of Economy in Bydgoszcz.

§ 5. Final remarks

These regulations shall enter into force on March 1, 2022.
